Dear Colleagues,

We hope you had a restful summer and your new school year is off to a smooth start. We are looking forward to welcoming our new class to campus, and we are excited to share these updates with you.

Application Updates

Beginning in the 2024–25 application cycle, standardized test scores will be required. Standardized tests are a means for all students, regardless of their background and life experience, to provide information that is predictive of success at Harvard and beyond. As with all parts of the application, test scores are considered in context and are used as one aspect of the whole-person review.

The College will accept the SAT or ACT to meet the standardized testing requirements. In exceptional cases when those tests are not accessible, a set of alternative standardized tests can meet the requirements. You can learn more on our website.

Our application will continue to include five required short-answer questions, one of which is a new question that allows students to reflect on their experiences with civil discourse. These questions allow all students to have the same opportunity to reflect on and share how their life experiences and academic and extracurricular activities shaped them, how they will engage with others at Harvard, and their aspirations for the future. These short-answer questions have allowed us to continue our focus on the whole person in the admissions process and reemphasize our commitment to intellectual vitality by promoting thoughtful discussion and consideration of different perspectives in classrooms, student groups, and social settings.

Expanded Financial and Student Support

We are pleased to share that under Harvard College's supportive financial aid program, which provides need-based assistance to all Harvard undergraduates regardless of their citizenship status, 24% of our students' families pay nothing for their child to attend Harvard.

This summer, the College welcomed its second cohort of the Harvard College Rising Scholars Program (RSP) to campus. RSP is a no-cost program that provides a seven-week summer intensive for select incoming first years. The Program continues during the students' first year at Harvard, and students will participate in dedicated programming that will help chart their academic paths.

Thank you for your important work on behalf of the students applying to Harvard College. We look forward to working with you in the months ahead.

Admissions: What Are We Looking For?

Some applicants demonstrate extraordinary promise in academic or research endeavors. Some show uncommon talent in other areas, such as leadership, performing arts, or athletics. Most of our students combine the best of both scholastic and extracurricular achievement. Personal qualities—integrity, maturity, strength of character, and concern for others—also play an important part in our evaluations.

Application

For undergraduate study, students apply to Harvard College as a whole. While applicants can indicate an interest in a particular academic area, they do not apply to a specific School or department. Harvard students declare their Concentration (field of study) at the end of their third semester.

Students may submit additional materials, such as art, music, or research, using the instructions in their Applicant Portal.

Financial Aid: Removing Economic Barriers

Applying for financial aid does not jeopardize any student's chance for admission, including international applicants. Indeed, the Admissions Committee may respond favorably to evidence that a candidate has overcome significant obstacles, financial or otherwise. All of Harvard's financial aid is awarded on the basis of demonstrated financial need—there are no academic, athletic, or meritbased awards. Harvard meets the demonstrated need of every student for all four years.

Our financial aid program requires no contribution from

Harvard families with annual incomes below \$85,000, asks no more than 10 percent of income for those with incomes up to \$150,000, and expects proportionally more from families with incomes more than \$150,000. Families at all income levels who have significant assets are asked to pay more than those without. Our financial aid officers work closely with families to ensure that Harvard is accessible to all admitted students. We do not require students to take out loans, although they are asked to cover their personal expenses through term-time work.

Our aid is entirely need-based, and grant eligibility is determined in the same manner for all admitted students regardless of nationality or citizenship status.
